## **Frequently Asked Questions**

- Who can issue proclamations? Government officials, such as governors, mayors, state legislators, members of Congress and the President of the United States sign and issue proclamations. This toolkit is specifically for obtaining a state proclamation through the Governor's office.
- Why should I request a proclamation? Proclamations are a great way to raise awareness and recognize important issues such as saving lives with ostomy surgery.
- When should I request a proclamation? The public can request a proclamation at any time during the year. Since they can take weeks to months to process a request they should be submitted well in advance of your need. In this case October 5, 2024.
- What should the wording of an Ostomy Awareness Day proclamation include? <u>Here</u> is a sample for you to download and include with your request. There is an example on the next page of the toolkit.

### What is a proclamation?

A proclamation is a government document that officially recognizes or designates an observance or event in your community (such as city or state). They can also be used to honor or commend individuals. Proclamations are not law or have any legal binding, but they are a useful tool to raise awareness.

### **Frequently Asked Questions**

 How do I request a proclamation from my Governor? For governors many will have a designated webpage on their website explaining the guidelines. Read the directions carefully. You will probably either have to submit an online form or email someone in the governor's office to request the proclamation. Links to state webpages for proclamations are included in this toolkit.

Requests must be made by a state resident. Some states require a request to be from a non-profit organization, <u>search</u> for a local UOAA Affliated Support Group to assist you or contact advocacy@ostomy.org for assistance.

All offices tend to have a disclaimer like this: "The Governor's Office reserves the right to deny requests at its discretion. Please note that we will be unable to process incomplete or inaccurate requests." They also reserve the right to edit any drafted materials/samples for final wording.

When you reach out to make an official request, be sure to include your personal ostomy story. They want to hear from constituents about why this is important to them and how it impacts the state.

### **SAMPLE PROCLAMATION**

#### Sample proclamation:

Ostomy Awareness Day "Ostomies Are Life-Savers"

WHEREAS, an ostomy is a type of surgery that creates an opening (stoma) in the abdomen that allows for the removal of bodily waste when a person has lost the normal function of digestive or urinary systems due to birth defects, colorectal cancer, bladder cancer, Crohn's disease, ulcerative colitis, and other medical conditions. They are also necessary in cases of severe abdominal or pelvic trauma resulting from accidents or from injuries sustained during military service. The bodily waste passes through the stoma into an ostomy 'pouch' on the outside of the body or in the case of continent diversion surgeries, an internal surgically created reservoir.

WHEREAS, approximately 725,000 to 1 million Americans have an ostomy, with approximately 100,000 new ostomy procedures performed each year and

WHEREAS, ostomy or continent diversion surgery can occur at any age and affects people from all ethnic backgrounds

WHEREAS, largely through the efforts of United Ostomy Associations of America, Inc., (UOAA) and its over 275 Affiliated Support Groups in the United States including [add the names of your state's support groups if known] \_\_\_\_\_ in the state of [state name] \_\_\_\_ Americans needing these surgeries are becoming more aware of the opportunities for education, mutual aid, advocacy and support that are of such great benefit to them and their families and

This day can serve as a reminder to the American public that this is a life-saving and life-restoring surgery and

WHEREAS [community, area, or organization] recognizes the need that public education and awareness is vital to ensure those who are living with an ostomy face no discrimination and are accepted as normal, healthy individuals. Through education and awareness we can erase the myths, stigma and embarrassment that are sometimes associated with having an ostomy and

WHEREAS [community, area, or organization] and other government and private sectors are deeply committed to the proper care and advancement of knowledge about bowel and urinary diversion surgery as a result of birth defects, disease, injury and other digestive disorders and

WHEREAS, to increase public acceptance of ostomy surgery and continent diversion surgery and to help the country better understand that "Ostomies are life-savers", [state, community] is designating "Ostomy Awareness Day" on October 5, 2024

• Depending on the office, you may have the official proclamation mailed, emailed or held in the office for you to pick up
